## MINNEAPOLIS CONFERENCE NEXT MONTH

Our fifth annual conference will be held June 17-20 at the Hubert H. Humphrey Center on the campus of the University of Minnesota, Minneapolis, MN, USA. The main conference begins on Wednesday, June 17, at 4 p.m., with a debate between Afzal Rahim (con) and Evert van de Vliert (pro) on the "Relevance of Blake and Mouton's Managerial Grid approach for conflict research today." It ends at noon on Saturday, June 20. There will be two preconference workshops from 1 to 3:30 on Wednesday.

An exciting program containing more than 130 papers and posters has been put together by William Ross and Dean Tjosvold. A preliminary copy of this program is enclosed.

The keynote address will be given by William Ury on the topic "Designing conflict resolution systems" on June 18 at 11 a.m. There will also be a public address by Roger Johnson on "Conflict management: Who is preparing the next generation?"

## IACM 1993 CONFERENCE IN LEUVEN, BELGIUM

We will hold our sixth annual conference at the Catholic University of Leuven in Belgium, June 17-20, 1993. This continues our tradition of meeting alternate years outside North America. Local arrangements will be in the hands of Jean Marie Hiltrop and Rene Bouwen.

## ELECTIONS AND APPOINTMENTS

We have had three elections since the last issue of Signal. Last spring, Evert van de Vliert was elected to the Board of Directors for a two-year term starting in June 1991. Evert is Professor in the Department of Social and Organizational Psychology at the University of Groningen.

Last fall, Dean Tjosvold was voted president-elect, and took office immediately because the office was vacant. Dean is University Professor in the Faculty of Business Administration at Simon Fraser University. Becoming president-elect puts one on the Board of Directors for three years: one year as president-elect, one year as president, and one year as past-president. This means that Dean will become president next month and past-president in June 1993.

One result of the most recent balloting were that Linda Putnam was endorsed as president-elect. She will take this office next month and become president in June 1993. Linda is Professor in the Department of Communication at Purdue University.

In addition, Trish Jones and Rod Kramer were elected to the Board of Directors, to take office next month for two-year terms, replacing Peter Carnevale and Linda Putnam. Trish is Associate Professor in the Department of Rhetoric and Communication at Temple University, and Rod is Associate Professor in the Graduate School of Business at Stanford University.

Jim Wall, Professor and Chair of the Department of Management at the University of Missouri, has been appointed our Executive Officer and now runs the IACM Business Office. The First European Conference on Peace-Making and Conflict Resolution was held April 24-27 in Anatalya, Turkey, under the leadership of Mehmet Gurkaynak of the Middle East Technical University. Many IACM members were in attendance, including Martin Euwema, Vasu Gounden, Louise Nieuwmeijer, Hugo Prein, Jacob Rabbie, Zofia Rummel-Syska, Dean Tjosvold, and Evert van de Vliert. Dean Tjosvold writes that there is a growing awareness that Europeans need conflict management knowledge to cope with the many pressing issues posed by Europe Without Borders and the collapse of the old regimes in Eastern Europe. The next conference of this organization will be in Madrid in April 1994.

The Ethnic Studies Network of the Centre for the Study of Conflict of the University of Ulster will hold a conference on Conflict and Change June 8-10.
